

BIGWEDDINGGIVEAWAY.COM GIVEAWAY OFFICIAL RULES

No purchase is necessary to enter or win. Making a purchase will not increase your chances of winning. Must be over 21 years of age to enter.

Void outside the 50 United States, District of Columbia, and where prohibited. Do not proceed to enter if you are not at least 21 years of age and a legal resident of, and located within, one of the 50 United States, or the District of Columbia, at the time of entry. Your participation in the Giveaway constitutes the entrant's ("Participant," "Entrant," "you," or "your") full and unconditional agreement to and acceptance of these Official Rules, including the decisions and interpretations of Sponsor and/or the judges, which are final and binding on all matters relating to the Giveaway.

1. GIVEAWAY PERIOD: The BIG WEDDING GIVEAWAY (BigWeddingGiveaway.com) (the "Giveaway") runs from Friday, June 1, 2018, at 12:01 AM Eastern Time ("ET") (the "Giveaway Start Date") thru Friday, May 31, 2019, at 11:59 PM ET (the "Giveaway End Date"). The period from the Giveaway Start Date through the Giveaway End Date is referred to as the "Giveaway Period." Sponsor's designated computer is the official time clock for the Giveaway.

2. SPONSOR: The Giveaway is sponsored collectively by those entities listed in the Addendum attached hereto (collectively, the "Sponsor"). Each of the entities provided in the attached Addendum, including their subsidiaries and affiliates, and any other partnering companies or agencies associated with the Giveaway, together, hereinafter will be referred to as the "Giveaway Partners."

3. HOW TO ENTER: During the Giveaway Period, there are three (3) ways to enter the Giveaway:

- a. Print Ballot Method of Entry: While supplies last, print ballots will be available at participating events ("Participating Event") conducted by Giveaway Partners, which may be advertised from time to time on those Giveaway Partners' websites (see Addendum for web address) or elsewhere. To enter the Giveaway, complete the print ballot entry form and return it to a Giveaway Partner representative at a Participating Event during the Giveaway Period. There is no cost to register or enter the Giveaway. Purchasing a ticket for entry into a Participating Event is not required to enter the Giveaway.
- b. Online Method of Entry: You may also enter the Giveaway by completing the entry form found on the websites provided in the Addendum (the "Websites").
- c. Mail-In Ballot Method of Entry: You may also mail a postcard with your full name, full address, city, state, telephone number, email address and age to: Big Wedding Giveaway P.O. Box 356, Ephrata, PA 17522.
- d. Regardless of method of entry, all entries must be received by the Giveaway End Date (Friday, May 31, 2019, at 11:59 PM ET). Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Any attempt by any participant to obtain more than one (1) entry per household by using multiple email

addresses, identities, profiles, registrations and logins, or any other methods will void that participant's entries and that participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Normal Internet access and usage charges imposed by your on-line service may apply. Participants do not need to make a purchase of any kind to enter the Giveaway. Regardless of method of entry, to enter the Giveaway, each entrant must complete the entry form with all required information (which will include your full name, full address, city, state, telephone number and age), and agree to these Official Rules. Photocopies of print ballot entries and mechanical reproductions submitted at an event and entries by any means which subvert the entry process will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

- e. Sponsor reserves the right, in its sole discretion, to: (i) verify any element of any entry, related materials or entrant's eligibility; (ii) to request additional information; and (iii) to disqualify any entrant whose participation may subject the Giveaway, Sponsor or Sponsor's advertisers, clients, or customers to controversy, negative publicity, scorn, or ridicule. By entering the Giveaway, you agree to provide any documentation or information deemed necessary by, and in a form acceptable to, Sponsor to satisfy the above requirement if asked by Sponsor to do so.

4. LIMIT: Maximum one (1) online entry per household or one (1) print ballot entry per household, as applicable, for the Giveaway Period.

5. ELIGIBILITY: The Giveaway is open to all legal residents of the 50 United States and Washington, D.C. who are 21 years old or older at the time of entry. Void elsewhere and where prohibited. Persons in the following categories are NOT eligible to enter the Giveaway or win Giveaway prizes: any person who on or after March 1, 2018, was or is: (a) a Giveaway Partner owner or employee; (b) a director, officer, employee, agent, or independent contractor of Sponsor, or its parent company, subsidiaries, affiliates, or service agencies; (c) any entities retained by Sponsor for the administration of the Giveaway; (d) an immediate family member (defined as parents, parents-in-law, children, siblings and spouse (including common law), regardless of where they reside) of any entity provided in the Addendum; or (e) any exhibitor or sponsor of an event organized by the entities provided in the Addendum, including any director, officer, employee, agent, or independent contractor thereof. Any other persons with whom any of the above are domiciled are also not eligible to enter the Giveaway or win Giveaway prizes.

6. WINNER SELECTION/DRAWING: The winner will be selected on or about June 15, 2019 (the "Drawing Date"), by a random drawing from all eligible entries received during the Giveaway Period. Odds of winning depend upon the number of eligible entries received.

7. WINNER NOTIFICATION: If your entry has been drawn as a winner, you will be contacted by telephone, email or mail, per the contact information indicated in your

online or print ballot entry form to confirm your entry and eligibility within two (2) weeks after the selection of the winning entry. To be confirmed a winner of any prize, you may be required to complete and return an affidavit of eligibility, release form, or other verifying documents requested by Sponsor before being awarded your prize. If a winner does not meet all eligibility requirements, has not complied with these Official Rules, cannot be contacted, does not respond within seven (7) days from the date Sponsor first tries to notify him/her, and/or the prize or prize notification is returned as undeliverable, such winner forfeits all rights to claim or receive the prize and an alternate winner may be selected. By accepting any prize, winner acknowledges compliance with these Official Rules. THE PRIZE IS AWARDED AS IS AND WITHOUT CONDITION, WARRANTY, GUARANTEE OR REPRESENTATION OF ANY KIND, EXPRESS OR IMPLIED (INCLUDING WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE).

8. PRIZE: Up to \$25,000 (ARV \$25,000) cash or check.

9. PRIZE DETAILS/RESTRICTIONS: In the Sponsor's sole discretion, the \$25,000 prize will be paid in the form of cash and/or as one or more checks as reimbursement to the winner for Qualified Wedding Expenses.

- a. A "Qualified Wedding Expense" is an expense that is (1) specifically related to the winner's wedding, including but not limited to attire, ceremony, reception venue and catering, photography, entertainment, and honeymoon, but specifically excluding all forms of alcohol; (2) related to a wedding that occurs no earlier than the date the winner entered the contest; (3) related to a wedding that occurs no later than December 15, 2020. Winner must submit copies of receipts and signed contracts (where applicable) for the expense within 60 days of their wedding date. See CONTACTING SPONSOR Section below for instructions for providing this documentation. Sponsor, in its sole discretion, has full and final authority in determining whether any purchase is a "Qualified Wedding Expense" for purposes of this Giveaway.
- b. In order to be reimbursed for Qualified Wedding Expenses, the winner must also submit a valid marriage license naming the selected winner as a party of a marriage taking place on or after The Giveaway Start Date and within 18 months from the Drawing Date to the Sponsor within 18 months of the Drawing Date. See CONTACTING SPONSOR Section below for instructions for providing this documentation.
- c. The "Remaining Balance" is the difference between the prize amount (i.e., \$25,000) and the total receipts for Qualified Wedding Expenses received by the Sponsor. After December 15, 2020, any Remaining Balance is forfeited.
- d. Sponsor reserves the right, at its sole discretion, to substitute prize (or portion thereof) with one of comparable or greater value. Under all circumstances, only one (1) prize will be awarded.

10. MINIMUM PRIZE AWARD: The Sponsor may, in its sole discretion, award a minimum prize in the amount of \$2,500 to the winner in the event that no Qualified Wedding Expenses are made by the winner within the time limits provided above.

All prize details are at Sponsor's sole discretion and are subject to change without notice. The winner must complete an IRS Form W-9 and Sponsor reserves the right to withhold all prizes until it receives a completed IRS Form W-9 from the winner. The winner will be issued a 1099 tax form for the actual value of the prize.

By entering and providing the required registration information, you acknowledge that Sponsor may send you information, samples, or special offers it believes may be of interest to you about the goods or services offered by Giveaway Partners. Sponsor may also include your name and postal address in postal address lists that Sponsor sells or rents to third parties for marketing purposes. Your email address will not be sold or rented to third parties. By entering the Giveaway, you acknowledge that you have read and understand the Privacy Policy and you agree to its terms.

14. PUBLICITY: Except where prohibited by law, entry into the Giveaway constitutes permission to use each entrant's name, hometown (city and state), voice, biographical information, likeness, photograph and any statements regarding this Giveaway in all media now known or hereafter discovered, for any purpose, including without limitation, in connection with, and to promote, market or advertise, the Giveaway, in whole or in part, without review, approval, credit or attribution, notification or payment from or to entrant or any person or entity, worldwide, in perpetuity, or on a winner's list, if applicable. By entering this Giveaway, you agree to be photographed and interviewed by the Sponsor for publicity purposes at least once and when given reasonable notice given by the Sponsor. Giveaway is subject to all applicable U. S.

federal, state and local laws and regulations. Winner will be issued an IRS 1099 tax form in the amount of the prize retail value as stated herein.

15. 17. GENERAL TERMS AND CONDITIONS: This Giveaway is void where prohibited by law. The Giveaway is subject to all applicable federal, state, and local laws and regulations. The Giveaway Partners reserve the right to terminate or withdraw the Giveaway at any time, by posting a notice online at BIGWEDDINGGIVEAWAY.COM. If the Giveaway is terminated before the Giveaway End Date, Sponsor will determine a winner in a random drawing from all eligible entries received as of the termination date. By participating in the Giveaway, each participant agrees to release and hold harmless the Giveaway Partners and each of their respective employees, officers, affiliates, parents, subsidiaries, directors, shareholders, agents and legal advisors (collectively the "Released Parties") from any and all losses, damages, rights, claims and actions of any kind in connection with the Giveaway or resulting from acceptance, possession or use of any prize, including, without limitation, any personal injury, death or property damage. Under no circumstances shall any of the Released Parties have any liability or responsibility for: (a) incorrect or inaccurate entry information, or faulty, failed, garbled or jumbled electronic data transmissions or print ballot submissions, (b) any unauthorized access to, or theft, destruction or alteration of entries at any point, (c) any

technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the Giveaway, (d) inaccessibility or unavailability of the Internet or a Giveaway site or any combination thereof, (5) any injury or damage to a participant's or to any other person's computer, laptop, tablet, cell phone, or other mobile device that may be related to or result from any attempt to participate in the Giveaway or download any materials in the Giveaway, or (6) any typographical error or other error in these Official Rules or in any other communication relating to the Giveaway.
